



RE: Increase in Clerk of Court's Fee Bill

Dear President Judge O'Dell Seneca

The Clerks of Courts Fee Bill provides for an increase in fees every three years, provided that the amount of the increase may not be greater than the percentage of increase in the Consumer Price Index for Urban Workers for the immediate three years preceding the last increase. The percentage by which our fees have increased is not more than 6%. The cumulative CPI for the immediate 3 years preceding the last increase was 6.3% (2001-2 7%, 2002-1 4% and 2003 2 2%)

The increase requires your approval. I have attached a copy of our new fee schedule and have also enclosed a copy of the referred to legislation for your convenience. Once approved, a copy will be forwarded to the Bar Association for publication.


