ORDER

AND NOW, this 22nd day of December, 2016, it is ORDERED, ADJUDGED, and DECREED that the Administrative Regulations for calendar year 2017 are as follows:

I. CALENDAR 2017

The following Court Calendar and judicial assignments are made for calendar year 2017. While this Administrative Order attempts to set forth a pattern designed to expedite the business of the court, the members of the court shall remain flexible so that change may be made if required to fulfill both our obligation and that of the practitioner to the administration of justice.

In the event of a recusal, that judge shall complete the Recusal Form and forward same to the President Judge for reassignment.

A. TRIAL TERMS

Jury trial terms for the calendar year are established as follows:

Jury selection for all cases shall be held on Monday of each week of the trial terms as set forth in the 2017 Court Calendar, and juror requests shall be made in writing at least one (1) week in advance of the trial term to the Court Administrator's Office.

Civil and criminal trials shall be scheduled for each term. Civil and criminal trial lists shall be prepared by the Court Administrator in cooperation with the Prothonotary and the Clerk of Courts. The civil lists and the criminal lists shall be managed by the individual judge to whom the cases have been assigned.

B. ARGUMENT COURT

No formal Argument Court shall be scheduled. In the event that a judge chooses to place a matter before a panel of three judges, that judge shall request the President Judge to convene a court *en banc* in accordance with the applicable local rule. The Order convening the panel shall set forth the date, time, and place where the argument will be held, together with a briefing schedule. The judge requesting the court *en banc* shall preside.

C. ORPHANS' COURT

D. DOMESTIC RELATIONS COURT

All support hearings shall be heard initially by the support master or as otherwise directed by the judge to whom the case is assigned.

II. JUDGE OF TERM

A. The Judge of the Term shall preside over morning Motions Court at 9:15 a.m., Monday through Friday. He/she shall decide unassigned civil matters brought before him/her and schedule hearings on those matters, in accordance with the local rules. He/she may refer to the President Judge for reassignment of those matters which, for some reason, she may be unable to hear. If the Judge of the Term is changed, the regularly assigned Judge of the Term shall notify the President Judge, the Court Administrator and the Washington County Bar Association. The Judge of the Term shall be available daily until 4:00 p.m. for emergency civil matters that are not assigned.

Judge Gilman: Tuesday through Friday at 9:15 a.m.

Judge Costanzo: Wednesdays at 9:30 a.m. (attorneys); 1:30 p.m. (unrepresented)

Judge Lucas: Monday at 1:15 p.m. and Thursday at 8:30 a.m.

Judge Faldowski: Tuesday through Thursday at 9:15 a.m. (when not general civil motions judge)

C. During those periods designated as administrative office weeks, attorneys shall be responsible to determine the availability of the Judge before notifying opposing counsel to appear for the presentation of a motion or other business.

All Fast-Track Appeals shall follow the above rotation.


All cases in which a driving under the influence charge is the highest graded offense are assigned to Judge John F. DiSalle for disposition; if the case is not resolved by a plea or dismissal, the case shall remain with him for trial or to reassign at his discretion.

All petitions requesting modification of bond for a criminal defendant in unassigned cases shall be presented to the Judge assigned to pre-trial services. In criminal cases assigned to a Judge, request for modification of bond shall be presented to that Judge. No bond shall be modified unless the defendant has been assessed by pre-trial services, absent exigent circumstances.

Petitions to enforce payment for restitution or to revoke probation or parole for failure to pay restitution shall be presented to the sentencing judge. If the sentencing judge no longer hears criminal cases, the petition shall be presented to the criminal motions judge.

VII. COVERAGE

With respect to all of the foregoing assignments, when a Judge is unavailable due to vacation, illness, conferences, etc., he/she shall be responsible for ensuring coverage and shall notify the President Judge and the Court Administrator.
